Background

Indonesia and South Korea are, in respects, comparable countries. Both have historically been strongly oriented toward economic development, resulting in high economic, political, social and cultural openness. Both countries enjoy mutually beneficial relations, both at the bilateral and regional levels. In the bilateral context, the two countries have established consular relations since 1966, and then formalized it into a diplomatic relationship since 1973. Currently, bilateral relations between the two countries have progressed very far, namely to become a "Special Strategic Partnership" since 2017. In the regional context, the two countries are equally active in cooperation in Southeast Asia and East Asia through ASEAN. Indonesia is a founding country as well as a member of ASEAN since 1967, while South Korea has established dialogue relations with ASEAN since 1989, and officially became ASEAN dialogue partner in 1991. Since 1997, the ASEAN-RoK Summit has been regularly held. The two countries are also members of the East Asia Summit which places ASEAN and South Korea with other major powers in the Indo-Pacific, namely China, Japan, the United States, Russia, India, Australia and New Zealand. ASEAN-Korea relations have also improved since 2010, from comprehensive cooperation to a strategic partnership.

The bilateral relations between Indonesia and South Korea have been shaped by various factors leading to the movement of goods, capital, socio-culture, and people to people exchange through international migration. The inter-spatial transfer of those movements has been defined by both countries' asymmetric needs and supported by the resource complementarity and the remarkable process of economic and political progress. Both have sought to safeguard their security and prosperity and open more widely accepted cooperation in various sectors by means of very close diplomatic and economic bilateral cooperation. The two countries actively support each other in international forum, such as in the G-20 and the nomination of each international organization's candidature.

On 25 November 2019, both governments have made an important milestone in bilateral economic cooperation by establishing Indonesia-Korea Comprehensive Economic Partnership Agreement (IK-CEPA). IK-CEPA covers trade in goods, including the element of tariff reduction, provisions on the origin of goods, customs procedures, trade facilitation, investment, economic cooperation,

institutional arrangements and capacity building. For Indonesia, IK-CEPA can bring the economy stronger, more competitive and attractive to South Korean investors by making Indonesia a new production hub to enter regional and global markets.

The two countries have a high socio-cultural exchange potential and lessons to be learned. The spread of Korean waves, such as K-POP (music), K-Drama, K-Foods and K-Beauty, has become increasingly popular for Indonesians, particularly among the millennial generation. During the Covid-19 outbreak, while staying at home, watching Korean drama was one of many Indonesians' favorite activities (Online survey by PMB LIPI, April 2020). Likewise, the increasing spread of Korean foods in several big cities in Indonesia shows the growing popularity of Korean culinary in Indonesia. Both countries' cooperation in developing halal tourism and halal cosmetic product will also be strategic to be considered in the future. In addition, the lessons learned from Korea's response in countering the onslaught of Covid-19 provide alternative and valuable lessons for Indonesia in responding to the resurgence of the virus.

South Korea is also one of the popular destination countries for Indonesian to find jobs overseas. Through its emerging economy, South Korea would require productive overseas migrant workers to support its industrial development and deal with the problem of fastest ageing population. With its excess of labor and demographic bonus, Indonesia attempts to provide employment by maximizing opportunities in abroad, including dispatching its labor in Korean industries, ranging from manufacturing, construction, fishery, and service sectors. With its large population and insufficient job opportunities, Indonesia uses high labor demands abroad to export its surplus labor and address its problem of the redundant workforce. The appeal of better salary and high demand of foreign labor in South Korea are the two main causal propulsion and increased trend for Indonesian to find jobs in South Korea. Therefore, these shared various characteristics and development, set Indonesia and South Korea in economic, politics, socio-culture importance at present and in the future.

Objectives and Activities

As a crucial part of understanding Indonesia-South Korea related issues, this international webinar is expected to contribute to a better understanding of strengthening the bilateral and diplomatic cooperation between the two countries. The webinar will discuss the current dynamics and policy challenges related to exchanging of goods, capital, socio-culture and people between Indonesia and South Korea. Additionally, this international webinar is part of the initial program (kick-off) to establish Indonesia-South Korea Research Group in IPSK LIPI and build a bridge to strengthen networking, research cooperation and collaboration among researchers on Indonesia-South Korea related issues.

The webinar will be divided into four sessions. The first session is welcoming speeches will be delivered by the HE Ambassador of Indonesia to Korea and the HE Ambassador of Korea to Indonesia. The second session is opening remarks by the Chairman of LIPI and President of Korea Foundation. The third session is presentation and discussion delivered by five speakers both from Indonesia and South Korea. This session will discuss a range of topics in politics, economy, social

and cultural related to Indonesia-Korea relationships. The fourth session is closing remarks by Director of Korea Foundation Jakarta Office and Deputy of Social Sciences and Humanities LIPI. The expected of speakers and topics at the presentation and discussion sessions are:

1. Speaker from Ministry of Foreign Affair Indonesia, presentation topics: IK CEPA: a Road to Pursue a more Suitable, Inclusive and Sustainable Cooperation or IK CEPA and the Future of Economic Cooperation between Indonesia and South Korea.
2. Speaker from ASEAN Secretariat, presentation topic: The Ongoing ASEAN-Korea Strategic Partnership: Challenges and Prospects to Build Stronger Connectivity
3. Scholar from Korea, presentation topic: the Korea Experiences in Response to the Pandemic of Covid-19.
4. Scholar from Korea, presentation topic: Gastro Diplomatic of Korean Waves: From Korea to the World; K-POP, K-Drama and K-Beauty.
5. Prof. Dr. Dewi Fortuna Anwar, MA- Senior Researcher at Research Center for Politics LIPI, presentation topic: The Dynamics of Indonesia-Korea Bilateral Relations: Some Strategic Issues to be concerned.
